

Terms and Conditions

1. Sole management of the Championships is vested with the Tournament Committee of the N.S.T.T.L. Inc.
2. NSTTL committee reserves the right to refuse or restrict entries and to cancel any event for which less than six (6) entries have been received.
3. Play will commence at 8:45am sharp on Saturday, 28th February, 2008 and will be continuous throughout the day at the discretion of the Tournament Committee.
4. Entry Fees must be paid on the day of the competition prior to playing your first match.
5. Round Robin rounds in events 1 and 2 will be the best of seven (5) games to eleven (11) points. The Knock-out rounds will be best of seven (7) games to eleven (11) points.
6. Where the number of entries permit, two (2) players from the Round Robin in events 1 and 2 will progress to the second round. Round Robin & Knock-out rounds in all other events will be played as best of five (5) games to eleven (11) points.
7. When numbers permit, the FIRST Round of each Event will be conducted on a Round Robin Basis.
8. The Tournament shall be conducted in accordance with the regulations of the ITTF/TTA. All competitors must be registered members of an Association affiliated with the ITTF.
9. Players at all times must participate in the NSTTL Open upon the principle of fair play, sportsmanship and participation.
10. Players will be advised of the start of their first match via the NSTTL Website. Which can be located at www.nsttl.org.au
11. Each match shall be controlled by an umpire whose decision shall be final on any point or fact.
12. Players will be required to umpire matches when called upon by the Match Manager.
13. Restricted Singles is Open to any player who is not seeded in Event 1.
14. Orange Balls will be used for every match, so appropriate clothing should be worn.
15. No claim whatsoever will be recognized should any player receive any injury during participation in the competition.
16. All players intending to enter multiple events, should give consideration to the fact that no more than five (5) minute intervals between finals will be allowed unless the Match Manager deems otherwise.
17. Player who have submitted an entry and have been included in the draw, will be liable to pay entry fees whether they attend on the day of competition or NOT.
18. A player is NOT ALLOWED to change a racket during a MATCH unless the racket is accidentally damaged so badly that it cannot be used. If it is discovered that a player has changed an undamaged racket, the umpire should immediately suspend play and report to the referee, The referee may disqualify the offending player.
